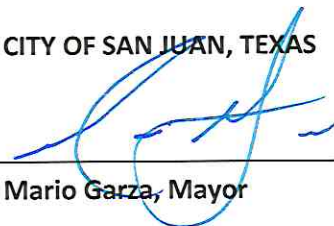
Commissioner Marco Villegas Motioned to Approve as recommended and Seconded by Commissioner Ernesto Guajardo. Motion Passed (4-0)
