A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SAN JUAN, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE RUNOFF ELECTION HELD ON JUNE 7, 2025, FOR THE PURPOSE OF ELECTING A COMMISSIONER PLACE 3

WHEREAS, on May 13, 2025, the City Commission of the City of San Juan adopted Resolution No. 2025-13, ordering a runoff election to be held on Saturday, June 7, 2025, to allow qualified voters of the City to elect a City Commissioner for Place 3; and

WHEREAS, said election was duly held on June 7, 2025, in accordance with the applicable provisions of the Texas Election Code and the City Charter; and

WHEREAS, in accordance with Chapter 67 of the Texas Election Code, the City Commission is required to canvass the election returns and officially declare the results of said election;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SAN JUAN THAT:

SECTION 1. The findings and recitals set forth above are hereby found to be true and correct and are adopted as part of this Resolution.

SECTION 2. The City Commission hereby finds and declares that the runoff election for City Commissioner Place 3 was duly and legally held on June 7, 2025, and that qualified voters of the City were given the opportunity to cast their ballots in said election.

SECTION 3. The official canvass of votes cast in the runoff election reveals the following results:
